

**DECISION OF THE COMMITTEE OF ADJUSTMENT
WITH REASONS RE:
APPLICATION FOR MINOR VARIANCE**

NOTICE: The last day for appealing this decision is the 19th day of September 2022. Village of Merrickville-Wolford Committee of Adjustment

RE AN APPLICATION BY: Allan Irish A-03-2022

LOCATION OF PROPERTY: 12058 County Road #15, Former Township of Wolford,
Village of Merrickville-Wolford

PURPOSE OF APPLICATION: The application requests relief from Merrickville-Wolford Zoning By-Law 23-08, as amended, to construct a 9.1m X 15.2m accessory outbuilding on the property which also includes a 6.1m X 15.2 m covered storage area. In total the accessory structure will be 232 m² (2,500 ft²) in size, exceeding the 140 m² maximum size for an accessory structure in the rural area. This application would permit a 232 m² accessory structure for personal use.

WE, the undersigned, in making the decision upon this application, have considered whether or not the variance requested was minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning By-law and the Official Plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law, as to whether or not this application has met the requirements of subsection 45(2) of the Planning Act.

CONCUR in the following decision and reasons for decision made on the 30th day of August 2022,

DECISION: That the Committee of Adjustment grant minor variance application A-03-2022 as applied for.

CONDITIONS -This decision has been made subject to the following conditions:

1. That no commercial use of the 232 m² accessory structure is permitted and that the building permit for the accessory structure indicate that no commercial use of the structure is permitted, *and this would be reflected in a Development Agreement registered on title, at the sole expense of the owner. END.*

REASON FOR DECISION:

The Committee considered the four tests of a minor variance with respect to proposed relief from Section 3.2.4 (1) Accessory Structure Lot Coverage to construct a 232 m² accessory structure and are satisfied the four tests have been met.
