#### 2021 Water & Wastewater Rates

On February 8, 2021, Council adopted By-Law No. 07-2021 to set the 2021 rates for water and wastewater. The rates were increased by 5%, effective January 1, 2021 and are reflected below.

#### The Base Rates will increase as follows:

Cubic meters of water used above the base rate will increase as follows:		
Water and Sewer Water only	\$7.41 per unit \$2.45 per unit	\$7.78 per unit \$2.58 per unit
Cubic meters of water included in base rate will remain the same:		
Residential Units Commercial Units	15 units per billing 30 units per billing	

The rate increase is reflected on the enclosed bill.

The Capital charge remains the same; it is not affected by the increase and is not included in the pricing above.

# **April Hydrant Flushing**

**Watermain / Hydrant Flushing** will take place from **April 6-30, 2021** between the hours of 8:00am and 3:00pm.

As a result of the flushing, water may be slightly discoloured or brown/reddish water. The water is entirely safe, however may not be aesthetically pleasing. To resolve this issue, run your taps for a short time until the colour is no longer present.

Weekly sampling is being conducted to ensure safe water.

### Did you know?

- Two types of sewers may be under municipal roads:
  - 1. **Sanitary sewers** carry wastewater from household drains such as toilets, showers/bathtubs & sinks to the treatment plant
  - 2. **Stormwater sewers** carry rainwater from catch basins & downspouts, releasing it into natural water courses like the Rideau River
- Downspouts & sump pumps connected to the sanitary sewer system needlessly send thousands of liters of clean rainwater to our sewage treatment plant
- This unnecessary demand on the plant consumes capacity that could limit the construction of new houses that would otherwise share the cost
- It is unlawful to connect your downspouts & sump pump to the sanitary sewer. The Ontario Building Code, Division B, 7.1.5.2 (1), states:

"Every storm drainage system shall be connected to a public storm sewage works...or a designated storm water disposal location but shall not be connected to a sanitary sewage works."

# How can you help?

- Disconnect your downspouts from your weeping tile & disconnect your sump pump from the sanitary sewer
- Install downspout extensions to carry roof runoff away from your foundation
- Install a rain barrel & use rainwater to water your plants & flowers
- Tell your neighbours
