

CORPORATION OF THE VILLAGE OF MERRICKVILLE - WOLFORD

BY-LAW NO. 07 - 16

BEING a By-Law to authorize the execution of an agreement between the Corporation of the Village of Merrickville - Wolford hereinafter called "The Municipality" **AND** the Rideau Valley Conservation Authority hereinafter called "the RVCA" with respect to the participation of the Municipality in promoting the RVCA's programs to improve the overall health of the Subwatershed

WHEREAS section 9(3) of the New Municipal Act, 2001 does authorize that the council of a local municipality may pass by-laws as part of its general municipal powers

AND WHEREAS the Council of the Corporation of the Village of Merrickville - Wolford does deem it expedient to enter into an agreement with the RVCA with respect to the participation of the Municipality in promoting the RVCA's programs to improve the overall health of the Subwatershed

NOW THEREFOR the Council of the Corporation of the Village of Merrickville - Wolford does enact as follows that:


- 1) The Corporation of the Village of Merrickville - Wolford enter into an Agreement with the RVCA with respect to the participation of the Municipality in promoting the RVCA's programs to improve the overall health of the Subwatershed, and that the said agreement shall be known as Schedule "A" attached hereto to this By-law.
- 2) The Mayor and the Clerk and/or their designates are hereby authorized to sign and execute such Agreement, attached as Schedule 'A', and affix the Corporation Seal thereto.

READ a third and final time and passed this of 11th day of April, 2016.

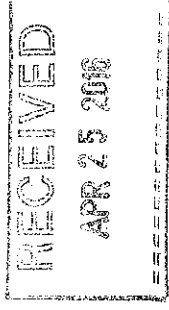

Mailing Address Use Agreement

This Agreement dated April 1, 2016

BETWEEN:

RIDEAU VALLEY CONSERVATION AUTHORITY
(Hereinafter called the "Conservation Authority")

- AND -

Corporation of the Village of Merrickville-Wolford
(Hereinafter called the "Municipality")

WHEREAS this Agreement is for the purpose of using landowner mailing addresses to promote Conservation Authority and Municipality stewardship programs, grants and technical support to improve the overall health of the Middle Rideau Subwatershed through the completion of tree planting, shoreline naturalization and erosion mitigation, septic re-inspection, well upgrades, farm BMPs and other water quality improvement projects. This promotion will be delivered by mail outs in 2016.

The Parties hereto agree as follows:

This Agreement shall be applicable to all lands within the municipality that fall within the boundaries of the Middle Rideau Subwatershed (attached Map – page 2) and shall be in place from April 1, 2016 to December 31, 2017.

The Conservation Authority will:


1. Carry out the promotional mail outs under the Municipality's direction
2. Send a list of requested addresses and roll numbers to the Municipality
3. Send final drafts of all promotional items to the Municipality for approval prior to mailing
4. Pay for the printing, addresses labeling and postage for all promotional materials mailed
5. Maintain records of mail out efforts

The Municipality will:

1. Provide direction to the Conservation Authority to carry out the promotional mail outs
2. Provide a list of requested addresses and roll numbers to the Conservation Authority
3. Review, provide comment and approve final drafts of all promotional items prior to mailing


