- Jim Luty, Speed Complaint County Road 23
 Inspector Dobson provided an update. Speed Spy will be set up as of May 28, 2019 on County Road 23 for data collection. After data analysis, a TMO will be dispatched to monitor the traffic
- 4. Community Safety Zone Read Street (2018)
 Chair Bower recommends dropping speed limit to 40km/hr. Mr. Pelletier not sure about speed, but would like to see the zone be named a Community Safety zone due to the presence of the school and the health centre. Mayor Struthers says 40km is still too fast. Inspector Dobson recommends that a study be completed first to determine if speed is the issue and the times of day etc. as it may not require a speed limit change. Any changes to the speed limit can become costly for a municipality to do. Conclusion, the location will be added to the schedule for the speed monitor.
