#### **Children's Programs:**

**StoryTime, French StoryTime, Saturday Play Days, Class visits**, and **Playgroup** visits have started up again.

We ran **Play Days** (with toys and games) every day during the first week of January (while school was still out), which was modestly successful.

The Merrickville Ladies Club has approached us about reviving the adult art group and hosting a knitting group. **Internet/Computers:** use levels remain consistent.

InterLibrary Loans: were down in December due to the holidays.

**Meeting Room:** There were fewer meetings in December, but this has started to pick up in January.

**Collection:** The Scholastic Warehouse Sale (for children's books) is back. Also continuing to weed the collection.



Dear County Councillors and Staff,

The Township of Montague would respectively request that options considered for Andrewsville bridge be ones that have the bridge open and operational for traffic all year. Options considered would be to keep it as a (one) 1 lane traffic bridge with a minimum weight of five (5) tons. To explore the option of reconditioning the bridge which would extend the life by twenty-five (25) years or price out replacement which would give a life span of seventy-five (75) years.

This area is recognized in the official plan of Montague as a settlement area (see below) and this bridge is a key component to the growth in this area.





Recently the Township replaced a box culvert bridge on Richardson Road (three) 3 km away from the crossover of Andrewsville Bridge. This was built wide enough for future road upgrades and guardrails as we plan for the future growth in that area. Montague has had one of the highest growth per capital in the County over the last (ten) 10 years. The Township has seen an increase in assessment of twenty-two-point six percent (22.6%) from 2016 to 2023 and each year continues to see growth. As internet and cell service continues to improve it is anticipated that the surge for people to relocate to rural Ontario will continue. Montague is a prime location for people to relocate with its close proximity to Carleton Place, Smiths Falls, Merrickville, North Grenville and the City of Ottawa. Our partners in North Grenville have seen exponential growth and both Communities are projected to have strong growth for many years to come.

The Andrewsville Bridge is used as a detour option which helps with traffic flows during bridge closures. It reduces the amount of CO2s when traffic is able to use a more direct route, which is approximately ten (10) minutes less driving time and reduced emissions to assist in a more environmental friendly option. It gives quicker access to emergency services like ambulances, police and fire service coming to the scene using their own vehicles, where in a medical emergency a difference of ten (10) minutes could be life or death.

There is currently a two (2) lane bridge in Merrickville and a one (1) lane bridge at Burritts Rapids as the only other crossings in the area. Having this single lane bridge makes two (2) full bridges which is the appropriate compliment for this area. When there is a bridge closure or accident, the flow of traffic is better managed and reduces congestion. This congestion is another environmental concern that needs to be considered.

It is the understanding of the Township of Montague that County Council has approved beyond the recommended option from Staff for the Blakeney Bridge in Mississippi Mills from one (1) lane to provide for two (lanes) to accommodate farm machinery traffic. The difference in the upgrade from a single to a double would have accommodated the request for the Andrewsville Bridge. The Township is supportive in the decision made by County Council as per the request from the Township of Mississippi Mills as they have the best knowledge of their area and what is required for the appropriate growth/users of the area. We respectfully request that County Council take into consideration the knowledge, growth, environmental impacts and well being of the Township of Montague residents as presented by the Township of Montague Council and staff similar to that of the Blakeney Bridge.



We request that both Counties look to the future growth of rural Ontario, the increasing age of our population and environmental impacts to ensure we continue to grow towards a sustainable, inclusive area that can provide effective and timely emergency services and reliable access to communities of growth.

## 1.6 Projections for OMATO

The projections contained in the current Official Plans of OMATO upper-tier or lower-tier municipalities produce a forecast similar to Scenario 2 presented here. Taking the existing projections and applying the same forecast growth rates forward to 2031 produces an overall OMATO total of 220,014. Our Scenario 2 projects 219,619 OMATO residents in 2031.


According to the most aggressive of the three scenarios, that population level would be reached in 2028. The most aggressive scenario calls for an OMATO population of 233,778 in 2031 and the most conservative projection would see OMATO grow to 204,619 people in that time frame.

# Official Plan Review – Summarized Points

This Official Plan is intended to guide the future development of the Township to the year 2028.

The Township's rural landscape is marked by six settlement areas – Andrewsville, Kilmarnock, Nolan's Corners, Numogate, Rosedale and Walsh Station.

#### 3.7.1 Intent of the Designation

The communities designated Settlement Area include the villages of Andrewsville, Kilmarnock, Nolan's Corners, Numogate, and Rosedale, as well as two areas on the periphery of the Town of Smiths Falls. These areas have historically served as local focal points where they provided a mix of local retail, service and social(cultural and residential opportunities for their surrounding

communities. Today, they still play important roles as social and cultural centres for the Township. ...the Settlement Area designation are intended to include a modest allowance for new development to occur, the boundaries of Rosedale and Andrewsville are intended to allow for significant new development possibilities.



#### 2.2 Growth Forecasts and Allocations

The Counties' population and employment growth forecasts guide planning decisions over the planning horizon. **The Counties and local municipalities should** plan to accommodate a total population of 75,960 persons and 16,760 jobs to 2031.

- 1. The distribution of recent growth in permanent population and housing within the Counties has been strongly influenced by proximity to the City of Ottawa, which has contributed to high levels of growth in North Grenville relative to other local municipalities.
- 2. All local municipalities have been experiencing net out-commuting, largely to job opportunities in the separated City of Brockville and in the City of Kingston, City of Ottawa and the United Counties of Stormont, Dundas and Glengarry. - 3. The extent of commuter-sheds relative to employment opportunities is an important consideration in the forecasts and represents a key determinant of the distribution of future population and housing growth within the Counties.

Based on the identified growth forecasts, this Plan allocates population and employment growth to each of the local municipalities based on the growth management framework and community settlement structure policies of this Plan.

#### BACKGROUND

The United Counties of Leeds and Grenville and the County of Lanark are responsible for several boundary bridges along the Rideau River, including Andrewsville Bridge. This bridge is a single lane, steel structure with wood planking on the driving surface. It was constructed in 1915. There is also a Parks Canada bridge to the south of the Andrewsville Bridge. The bridges are connected by a causeway and road. Both bridges have maximum limits of 5 tonnes.

In early 2012, a transport truck crossed the bridges causing damage to both bridges. The Counties and Parks Canada closed both bridges for a period of approximately 9 months. Counties Council agreed to invest \$50,000 over 4 years for capital repairs, providing the County of Lanark committed the same. Both Counties agreed and in early 2013 the bridge repairs were completed and a barrier erected to prohibit large vehicles from crossing the bridge. The bridge continues to be posted as 5 tonnes maximum weight.

In 2012, Counties Council debated whether to repair the bridge as well as whether to re-open the bridge to vehicular traffic. The replacement cost of the bridge and adjoining causeway, in 2012 dollars, was \$2.5 million. There are two bridges within 8 to 10 kilometres on either side of the Andrewsville Bridge. The vehicular traffic across the bridge was minimal and thus, Council grappled with spending significant dollars on the bridge.

#### DISCUSSION/ALTERNATIVES

The letter from the Township of Montague was also sent to the County of Lanark. Lanark's Public Works Committee did receive the letter, but no discussion was held and no action was taken. It was received for information purposes only.

The letter refers to regular maintenance and repair. Based on the Counties resolution passed in 2012 (attached), the commitment is in place until the end of 2016. Similarly, the costs of ongoing maintenance of the bridge are operational expenses that are shared between the two Counties. The County of Lanark is responsible for the maintenance and invoices the Counties for 50% of its annual costs.

The bridge is maintained and managed by Lanark County and costs are evenly shared between Lanark County and the United Counties of Leeds and Grenville.

Lanark County Council passed the following resolution at its Council meeting of September 26, 2018 (following the Public Works Committee meeting):

- "1. The Director of Public Works is hereby authorized to put an annual, temporary closure on the Andrewsville Bridge from December 1 until March 31, each year.
- 2. This By-law will come into force on the date of its passing."

#### DISCUSSION/ALTERNATIVES

Keystone Bridge Management Corp.'s "Andrewsville Bridge 2018 Wading Inspection" Report is attached as Appendix "A".

The immediate repairs are noted on Page 4 of the Report under Recommendations - Immediate Needs. Subject to prices received, it is anticipated that the costs of the above noted work will range from \$75,000 to \$100,000, of which the United Counties of Leeds and Grenville is responsible for 50% of the cost.

The estimated cost of a complete bridge replacement is \$3.3 Million Dollars.

Two options are provided:

Option 1 (Recommended):

Complete the necessary immediate repairs and pass a By-Law to effect an annual, temporary road closure to vehicular traffic from December 1 through March 31.

# Mis-representation of the Virtual Consultation

## Public consultation for Andrewsville Bridge open until Dec. 2

The public consultation process to determine the preferred option for the future of the Andrewsville Bridge is underway and open until Dec. 2 in the form of a virtual Public Consultation Centre (PCC). This is part of the Class Environmental Assessment (EA) process that began in April.

The bridge, located at the hamlet of Andrewsville in Montague Township, is more than 100 years old and nearing the end of its useful life. It spans the Rideau River, providing access to the Parks Canada swing bridge that crosses the Rideau Canal at Nicholson's Locks. Lanark County and the United Counties of Leeds & Grenville (UCLG) share jurisdiction for the bridge, which has had a 5- tonne load limit since 1952 and is used by fewer than 200 vehicles per day. Since 2018 it has closed to traffic each year from Dec.1 to March 1 to eliminate further corrosion from de-icing materials. The latest inspection report recommended closing the bridge within five years and completing the EA study to investigate further options.

"The options review is a priority for the counties due to the bridge's age and condition, posted weight restriction and seasonal operation, and its potential cultural heritage value," said Sean Derouin, Lanark County public works manager. "As part of the EA process, all future options for the bridge will be reviewed to determine the preferred solution."

The Class EA requires public and stakeholder consultation, evaluation of alternatives, an assessment of potential impacts of the proposed alternatives and identification of measures to mitigate any adverse impacts. Upon completion of the study, an Environmental Study Report documenting the process will be available for public review and comments for a period of 30 calendar days.

Consultation is a requirement in the class EA process, as well as an evaluation of alternatives, potential impacts and identification of ways to mitigate adverse impacts.


#### 2.2 Growth Forecasts and Allocations

The Counties' population and employment growth forecasts guide planning decisions over the planning horizon. The Counties and local municipalities should plan to accommodate a total population of 75,960 persons and 16,760 jobs to 2031.

- 1. The distribution of recent growth in permanent population and housing within the Counties has been strongly influenced by proximity to the City of Ottawa, which has contributed to high levels of growth in North Grenville relative to other local municipalities.
- 2. All local municipalities have been experiencing net out-commuting, largely to job opportunities in the separated City of Brockville and in the City of Kingston, City of Ottawa and the United Counties of Stormont, Dundas and Glengarry. Out-commuting from the United Counties of Leeds and Grenville residents is anticipated to continue over the Plan horizon.
- 3. The extent of commuter-sheds relative to employment opportunities is an important consideration in the forecasts and represents a key determinant of the distribution of future population and housing growth within the Counties.

Based on the identified growth forecasts, this Plan allocates population and employment growth to each of the local municipalities based on the growth management framework and community settlement structure policies of this Plan.

- g) Local municipalities are **encouraged to promote the long term economic prosperity of settlement areas** that support the local context through the following:
- **ii.** Plan to optimize the use of land, resources, infrastructure, electricity generation facilities and transmission and distribution systems, and public service facilities to accommodate forecasted growth and meet long term requirements.
- iii. Identify appropriate locations and promote opportunities for redevelopment, intensification and revitalization in areas that have sufficient existing or planned infrastructure.
- iv. Provide for an efficient, cost-effective, reliable, multimodal transportation system, where existing or planned, that is integrated with adjacent systems and those of other jurisdictions and is appropriate to address expected growth.





RE: Legislative Process for Filling a Council Vacancy

**OBJECTIVE:** To provide Council with an overview of the process for filling a

Council vacancy.

#### **RECOMMENDATION:**

THAT: Council does hereby receive report CAO-01-2023, being a report to describe the legislative process for filling a vacant seat on Council.

#### **BACKGROUND:**

The *Municipal Act, 2001, c.25*, Section 259(1)(d), indicates that the office of a member of council of a municipality becomes vacant if the member resigns from his or her office in accordance with Section 260. Section 260 indicates that a member of council of a municipality may resign from office by notice in writing filed with the clerk of the municipality.

On January 25, 2023, Councillor Mark Oldfield submitted notice in writing with the clerk of his resignation from his Merrickville Ward Councillor seat. In Council's next meeting on January 30, 2023, Council declared the Council seat vacant via Resolution R-029-23 in compliance with Section 262(1) which requires Council to declare the office to be vacant at its next meeting following submission of the resignation.

#### **ANALYSIS:**

When a vacancy on Council does occur, Council is faced with the decision of how to fill the vacant seat for the remainder of the term. The *Municipal Act, 2001, 263(1)* provides the following two options:

- 263(1) Filling Vacancies If a vacancy occurs in the office of a member of council, the municipality shall, subject to this section:
  - a) fill the vacancy by appointing a person who has consented to accept the office if appointed; or
  - b) require a by-election to be held to fill the vacancy in accordance with the Municipal Elections Act.

The *Municipal Act*, 2001, 263(5) regarding the Rules applying to filling vacancies indicates:

263 (5) The following rules apply to filling vacancies:

- 1. Within 60 days after the day a declaration of vacancy is made with respect to the vacancy under section 262, the municipality shall,
  - i. appoint a person to fill the vacancy under subsection (1) or (4), or
  - ii. pass a by-law requiring a by-election be held to fill the vacancy under subsection (1).

If Council chooses to pass a by-law to call a by-election, Section 65 of the *Municipal Elections Act* applies and Section 65(4) requires the Clerk to fix the nomination day to be not less than 30 and not more than 60 days after the by-law calling for a by-election is passed. A by-election requires Council to pass a by-law ordering the election and voting day is then 45 days after nomination day.

A person appointed or elected to fill a vacancy must be:

- a Canadian citizen;
- at least 18 years of age;
- a resident of the Village of Merrickville-Wolford, or be the owner or tenant of land, or the spouse of the owner of tenant of land;
- not prohibited from voting in a municipal election by any legislation; and
- not prohibited from holding the office under the Municipal Act or any other legislation.

In accordance with Municipal Act Section 264, the new Councillor will serve from the time their oath of office is taken to the end of the current term of Council.

#### **BUDGET/LEGAL IMPLICATIONS:**

Budget implications will vary depending on which method is chosen to fill the Council vacancy. The 2018 municipal election expenses were \$12,220 and, due to additional costs associated with the pandemic, the 2022 municipal election expenses were \$20,873.87.

#### LINKS TO STRATEGIC PLANS:

On January 23, 2017, the Council of the Corporation of the Village of Merrickville-Wolford passed By-Law 10-17, being a by-law to adopt the Merrickville-Wolford Strategic Plan 2017-2025.

# A BY-LAW TO AUTHORIZE A FRANCHISE AGREEMENT BETWEEN THE CORPORATION OF THE VILLAGE OF MERRICKVILLE-WOLFORD and ENBRIDGE GAS INC.

**WHEREAS** the Council of the Corporation of the Village of Merrickville-Wolford deems it expedient to enter into the attached franchise agreement (the "Franchise Agreement") with Enbridge Gas Inc.;

**AND WHEREAS** the Ontario Energy Board by its Order issued pursuant to the *Municipal Franchises Act* has approved the terms and conditions upon which and the period for which the franchise provided in the Franchise Agreement is proposed to be granted, and has declared and directed that the assent of the municipal electors in respect of this By-Law is not necessary:

**NOW THEREFORE** the Council of the Corporation of the Village of Merrickville-Wolford enacts as follows:

- 1. **THAT** the Franchise Agreement between the Corporation of the Village of Merrickville-Wolford and Enbridge Gas Inc. attached hereto and forming part of this by-law, is hereby authorized and the franchise provided for therein is hereby granted.
- 2. **THAT** the Mayor and CAO / Clerk be and they are hereby authorized and instructed on behalf of the Corporation of the Village of Merrickville-Wolford to enter into and execute under its corporate seal and deliver the Franchise Agreement, which is hereby incorporated into and forming part of this By-Law.
- 3. **THAT** the following by-law be hereby repealed:
  - By-law #18-02 for the Corporation of the Village of Merrickville-Wolford, passed in Council on the 28<sup>th</sup> day of October, 2002.
- 4. **THAT** this by-law shall come into force and take effect as of the final passing thereof.

#### 2000 Model Franchise Agreement

THIS AGREEMENT effective this

day of

, 2023

BETWEEN:

#### THE CORPORATION OF THE VILLAGE OF MERRICKVILLE-WOLFORD

hereinafter called the "Corporation"

- and -

#### **ENBRIDGE GAS INC.**

hereinafter called the "Gas Company"

WHEREAS the Gas Company desires to distribute, store and transmit gas in the Municipality upon the terms and conditions of this Agreement;

AND WHEREAS by by-law passed by the Council of the Corporation (the "By-law"), the duly authorized officers have been authorized and directed to execute this Agreement on behalf of the Corporation;

THEREFORE, the Corporation and the Gas Company agree as follows:

#### Part I - Definitions

#### 1. In this Agreement

- (a) "decommissioned" and "decommissions" when used in connection with parts of the gas system, mean any parts of the gas system taken out of active use and purged in accordance with the applicable CSA standards and in no way affects the use of the term 'abandoned' pipeline for the purposes of the Assessment Act;
- (b) "Engineer/Road Superintendent" means the most senior individual employed by the Corporation with responsibilities for highways within the Municipality or the person designated by such senior employee or such other person as may from time to time be designated by the Council of the Corporation;

- (c) "gas" means natural gas, manufactured gas, synthetic natural gas, liquefied petroleum gas or propane-air gas, or a mixture of any of them, but does not include a liquefied petroleum gas that is distributed by means other than a pipeline;
- (d) "gas system" means such mains, plants, pipes, conduits, services, valves, regulators, curb boxes, stations, drips or such other equipment as the Gas Company may require or deem desirable for the distribution, storage and transmission of gas in or through the Municipality;
- (e) "highway" means all common and public highways and shall include any bridge, viaduct or structure forming part of a highway, and any public square, road allowance or walkway and shall include not only the travelled portion of such highway, but also ditches, driveways, sidewalks, and sodded areas forming part of the road allowance now or at any time during the term hereof under the jurisdiction of the Corporation;
- (f) "Model Franchise Agreement" means the form of agreement which the Ontario Energy Board uses as a standard when considering applications under the *Municipal Franchises Act*. The Model Franchise Agreement may be changed from time to time by the Ontario Energy Board;
- (g) "Municipality" means the territorial limits of the Corporation on the date when this Agreement takes effect, and any territory which may thereafter be brought within the jurisdiction of the Corporation;
- (h) "Plan" means the plan described in Paragraph 5 of this Agreement required to be filed by the Gas Company with the Engineer/Road Superintendent prior to commencement of work on the gas system; and
- (i) whenever the singular, masculine or feminine is used in this Agreement, it shall be considered as if the plural, feminine or masculine has been used where the context of the Agreement so requires.

#### Part II - Rights Granted

#### 2. To provide gas service

The consent of the Corporation is hereby given and granted to the Gas Company to distribute, store and transmit gas in and through the Municipality to the Corporation and to the inhabitants of the Municipality.

#### 3. To Use Highways

Subject to the terms and conditions of this Agreement the consent of the Corporation is hereby given and granted to the Gas Company to enter upon all highways now or at any time hereafter under the jurisdiction of the Corporation and to lay, construct, maintain, replace, remove, operate and repair a gas system for the distribution, storage and transmission of gas in and through the Municipality.

#### 4. Duration of Agreement and Renewal Procedures

(a) If the Corporation has not previously received gas distribution services, the rights hereby given and granted shall be for a term of 20 years from the date of final passing of the By-law.

or

- (b) If the Corporation has previously received gas distribution services, the rights hereby given and granted shall be for a term of 20 years from the date of final passing of the By-law provided that, if during the 20 year term of this Agreement, the Model Franchise Agreement is changed, then on the 7<sup>th</sup> anniversary and on the 14<sup>th</sup> anniversary of the date of the passing of the By-law, this Agreement shall be deemed to be amended to incorporate any changes in the Model Franchise Agreement in effect on such anniversary dates. Such deemed amendments shall not apply to alter the 20 year term.
- (c) At any time within two years prior to the expiration of this Agreement, either party may give notice to the other that it desires to enter into negotiations for a renewed franchise upon such terms and conditions as may be agreed upon. Until such renewal has been settled, the terms and conditions of this Agreement shall continue, notwithstanding the expiration of this Agreement. This shall not preclude either party from applying to the Ontario Energy Board for a renewal of the Agreement pursuant to section 10 of the *Municipal Franchises Act*.

#### Part III - Conditions

#### 5. Approval of Construction

- (a) The Gas Company shall not undertake any excavation, opening or work which will disturb or interfere with the surface of the travelled portion of any highway unless a permit therefor has first been obtained from the Engineer/Road Superintendent and all work done by the Gas Company shall be to his satisfaction.
- (b) Prior to the commencement of work on the gas system, or any extensions or changes to it (except service laterals which do not interfere with municipal works in the highway), the Gas Company shall file with the Engineer/Road Superintendent a Plan, satisfactory to the Engineer/Road Superintendent, drawn to scale and of sufficient detail considering the complexity of the specific locations involved, showing the highways in which it proposes to lay its gas system and the particular parts thereof it proposes to occupy.
- (c) The Plan filed by the Gas Company shall include geodetic information for a particular location:
  - (i) where circumstances are complex, in order to facilitate known projects, including projects which are reasonably anticipated by the Engineer/Road Superintendent, or
  - (ii) when requested, where the Corporation has geodetic information for its own services and all others at the same location.
- (d) The Engineer/Road Superintendent may require sections of the gas system to be laid at greater depth than required by the latest CSA standard for gas pipeline systems to facilitate known projects or to correct known highway deficiencies.
- (e) Prior to the commencement of work on the gas system, the Engineer/Road Superintendent must approve the location of the work as shown on the Plan filed by the Gas Company, the timing of the work and any terms and conditions relating to the installation of the work.
- (f) In addition to the requirements of this Agreement, if the Gas Company proposes to affix any part of the gas system to a bridge, viaduct or other structure, if the Engineer/Road Superintendent approves this proposal, he may require the Gas Company to comply with special conditions or to enter into a separate agreement as a condition of the approval of this part of the construction of the gas system.

- (g) Where the gas system may affect a municipal drain, the Gas Company shall also file a copy of the Plan with the Corporation's Drainage Superintendent for purposes of the *Drainage Act*, or such other person designated by the Corporation as responsible for the drain.
- (h) The Gas Company shall not deviate from the approved location for any part of the gas system unless the prior approval of the Engineer/Road Superintendent to do so is received.
- (i) The Engineer/Road Superintendent's approval, where required throughout this Paragraph, shall not be unreasonably withheld.
- (j) The approval of the Engineer/Road Superintendent is not a representation or warranty as to the state of repair of the highway or the suitability of the highway for the gas system.

#### 6. As Built Drawings

The Gas Company shall, within six months of completing the installation of any part of the gas system, provide two copies of "as built" drawings to the Engineer/Road Superintendent. These drawings must be sufficient to accurately establish the location, depth (measurement between the top of the gas system and the ground surface at the time of installation) and distance of the gas system. The "as built" drawings shall be of the same quality as the Plan and, if the approved pre-construction plan included elevations that were geodetically referenced, the "as built" drawings shall similarly include elevations that are geodetically referenced. Upon the request of the Engineer/Road Superintendent, the Gas Company shall provide one copy of the drawings in an electronic format and one copy as a hard copy drawing.

#### 7. Emergencies

In the event of an emergency involving the gas system, the Gas Company shall proceed with the work required to deal with the emergency, and in any instance where prior approval of the Engineer/Road Superintendent is normally required for the work, the Gas Company shall use its best efforts to immediately notify the Engineer/Road Superintendent of the location and nature of the emergency and the work being done and, if it deems appropriate, notify the police force, fire or other emergency services having jurisdiction. The Gas Company shall provide the Engineer/Road Superintendent with at least one 24 hour emergency contact for the Gas Company and shall ensure the contacts are current.

#### 8. Restoration

The Gas Company shall well and sufficiently restore, to the reasonable satisfaction of the Engineer/Road Superintendent, all highways, municipal works or improvements which it may excavate or interfere with in the course of laying, constructing, repairing or removing its gas system, and shall make good any settling or subsidence thereafter caused by such excavation or interference. If the Gas Company fails at any time to do any work required by this Paragraph within a reasonable period of time, the Corporation may do or cause such work to be done and the Gas Company shall, on demand, pay the Corporation's reasonably incurred costs, as certified by the Engineer/Road Superintendent.

#### 9. Indemnification

The Gas Company shall, at all times, indemnify and save harmless the Corporation from and against all claims, including costs related thereto, for all damages or injuries including death to any person or persons and for damage to any property, arising out of the Gas Company operating, constructing, and maintaining its gas system in the Municipality, or utilizing its gas system for the carriage of gas owned by others. Provided that the Gas Company shall not be required to indemnify or save harmless the Corporation from and against claims, including costs related thereto, which it may incur by reason of damages or injuries including death to any person or persons and for damage to any property, resulting from the negligence or wrongful act of the Corporation, its servants, agents or employees.

#### 10. Insurance

- (a) The Gas Company shall maintain Comprehensive General Liability Insurance in sufficient amount and description as shall protect the Gas Company and the Corporation from claims for which the Gas Company is obliged to indemnify the Corporation under Paragraph 9. The insurance policy shall identify the Corporation as an additional named insured, but only with respect to the operation of the named insured (the Gas Company). The insurance policy shall not lapse or be cancelled without sixty (60) days' prior written notice to the Corporation by the Gas Company.
- (b) The issuance of an insurance policy as provided in this Paragraph shall not be construed as relieving the Gas Company of liability not covered by such insurance or in excess of the policy limits of such insurance.
- (c) Upon request by the Corporation, the Gas Company shall confirm that premiums for such insurance have been paid and that such insurance is in full force and effect.

#### 11. Alternative Easement

The Corporation agrees, in the event of the proposed sale or closing of any highway or any part of a highway where there is a gas line in existence, to give the Gas Company reasonable notice of such proposed sale or closing and, if it is feasible, to provide the Gas Company with easements over that part of the highway proposed to be sold or closed sufficient to allow the Gas Company to preserve any part of the gas system in its then existing location. In the event that such easements cannot be provided, the Corporation and the Gas Company shall share the cost of relocating or altering the gas system to facilitate continuity of gas service, as provided for in Paragraph 12 of this Agreement.

#### 12. Pipeline Relocation

- (a) If in the course of constructing, reconstructing, changing, altering or improving any highway or any municipal works, the Corporation deems that it is necessary to take up, remove or change the location of any part of the gas system, the Gas Company shall, upon notice to do so, remove and/or relocate within a reasonable period of time such part of the gas system to a location approved by the Engineer/Road Superintendent.
- (b) Where any part of the gas system relocated in accordance with this Paragraph is located on a bridge, viaduct or structure, the Gas Company shall alter or relocate that part of the gas system at its sole expense.
- (c) Where any part of the gas system relocated in accordance with this Paragraph is located other than on a bridge, viaduct or structure, the costs of relocation shall be shared between the Corporation and the Gas Company on the basis of the total relocation costs, excluding the value of any upgrading of the gas system, and deducting any contribution paid to the Gas Company by others in respect to such relocation; and for these purposes, the total relocation costs shall be the aggregate of the following:
  - (i) the amount paid to Gas Company employees up to and including field supervisors for the hours worked on the project plus the current cost of fringe benefits for these employees,
  - (ii) the amount paid for rental equipment while in use on the project and an amount, charged at the unit rate, for Gas Company equipment while in use on the project,
  - (iii) the amount paid by the Gas Company to contractors for work related to the project,

- (iv) the cost to the Gas Company for materials used in connection with the project, and
- (v) a reasonable amount for project engineering and project administrative costs which shall be 22.5% of the aggregate of the amounts determined in items (i), (ii), (iii) and (iv) above.
- (d) The total relocation costs as calculated above shall be paid 35% by the Corporation and 65% by the Gas Company, except where the part of the gas system required to be moved is located in an unassumed road or in an unopened road allowance and the Corporation has not approved its location, in which case the Gas Company shall pay 100% of the relocation costs.

#### Part IV - Procedural And Other Matters

#### 13. Municipal By-laws of General Application

The Agreement is subject to the provisions of all regulating statutes and all municipal by-laws of general application, except by-laws which have the effect of amending this Agreement.

#### 14. Giving Notice

Notices may be delivered to, sent by facsimile or mailed by prepaid registered post to the Gas Company at its head office or to the authorized officers of the Corporation at its municipal offices, as the case may be.

#### 15. Disposition of Gas System

- (a) If the Gas Company decommissions part of its gas system affixed to a bridge, viaduct or structure, the Gas Company shall, at its sole expense, remove the part of its gas system affixed to the bridge, viaduct or structure.
- (b) If the Gas Company decommissions any other part of its gas system, it shall have the right, but is not required, to remove that part of its gas system. It may exercise its right to remove the decommissioned parts of its gas system by giving notice of its intention to do so by filing a Plan as required by Paragraph 5 of this Agreement for approval by the Engineer/Road Superintendent. If the Gas Company does not remove the part of the gas system it has decommissioned and the Corporation requires the removal of all or any part of the decommissioned gas system for the purpose of altering or improving a highway or in order to facilitate the construction of utility or other works in any highway, the Corporation may remove and dispose of so much of the decommissioned gas system

as the Corporation may require for such purposes and neither party shall have recourse against the other for any loss, cost, expense or damage occasioned thereby. If the Gas Company has not removed the part of the gas system it has decommissioned and the Corporation requires the removal of all or any part of the decommissioned gas system for the purpose of altering or improving a highway or in order to facilitate the construction of utility or other works in a highway, the Gas Company may elect to relocate the decommissioned gas system and in that event Paragraph 12 applies to the cost of relocation.

#### 16. Use of Decommissioned Gas System

- (a) The Gas Company shall provide promptly to the Corporation, to the extent such information is known:
  - (i) the names and addresses of all third parties who use decommissioned parts of the gas system for purposes other than the transmission or distribution of gas; and
  - (ii) the location of all proposed and existing decommissioned parts of the gas system used for purposes other than the transmission or distribution of gas.
- (b) The Gas Company may allow a third party to use a decommissioned part of the gas system for purposes other than the transmission or distribution of gas and may charge a fee for that third party use, provided
  - (i) the third party has entered into a municipal access agreement with the Corporation; and
  - (ii) the Gas Company does not charge a fee for the third party's right of access to the highways.
- (c) Decommissioned parts of the gas system used for purposes other than the transmission or distribution of gas are not subject to the provisions of this Agreement. For decommissioned parts of the gas system used for purposes other than the transmission and distribution of gas, issues such as relocation costs will be governed by the relevant municipal access agreement.

#### 17 Franchise Handbook

The Parties acknowledge that operating decisions sometimes require a greater level of detail than that which is appropriately included in this Agreement. The Parties agree to look for guidance on such matters to the Franchise Handbook prepared by the Association of Municipalities of Ontario and the gas utility companies, as may be amended from time to time.
