Merrickville Public Library Board's meeting was held on February 9, 2023 at 7:30 pm via Zoom.

- 1. Meeting called to order at 7:34 pm. The Board Chair requested that it be noted that John Harris is unlikely to be able to participate on the Board for the foreseeable future due to health issues, and that Timothy Molloy (former Council Representative) has not been participating on the Board since the previous Council term ended.
- 2. Declaration of Pecuniary Interest: None.
- 3. Adoption of Agenda: Moved by Olivia; seconded by Brian. ADOPTED.
- 4. Approval of Minutes:
 - Jan 11/23 board meeting Moved by Brian; seconded by Olivia. APPROVED.
- **5. Correspondence**: None.
- 6. Questions/ Presentations from Public: None
- **7. Friends of the Library Report:** Cheryl Geeson is the new Chair of the Friends. The group took Mary Kate and Linda to lunch and have an upcoming meeting to plan their spring fundraisers.
- 8. Report from Council: N/A
- 9. Librarian's Report: see below.
- 10. Other Business:
 - a) Updates re:New Board: Application forms have recently gone out. Deadline is Mar 31, so the new board is expected in April.
 - b) Year End:
 - i. Annual Survey / Annual Report: almost all of the data is compiled for the Annual Survey (required to receive the Provincial Library Operating Grant), will submit after updated year end financial data is available. Expect to have a draft Annual Report for next meeting.
 - **ii. Seed Library Report 2022:** Reviewed report. This will be distributed to our partners and posted on the library's website.
 - c) Building:
 - i. Update: Building Exterior Work: still pending.

Furnace: The furnace/propane connection required more repairs; it stopped working twice in Jan/Feb. We had to cancel a couple of programs, but have been able to remain open otherwise. It is hoped that this most recent fix will solve our problems, but the furnace is 14 years of a projected 15-20 year lifespan.

- ii. Water Unit: According to information from OCWA, the water treatment unit in the Library is failing and it is more cost-effective to replace than repair. According to Public Works, this is entirely the Library's responsibility, which means that OCWA will not handle the replacement (OCWA's contract is with the municipality, not the Library). On further discussion (re: municipal building, municipal well, municipal contract with OCWA which has been doing all the testing, maintenance, and previous purchase and installation of the water equipment all this time), Public Works has offered to manage this so that OCWA will handle the replacement, if the Library authorizes payment. It is recommended that the Board revise their capital grant request to include the cost of this new unit. Note: OCWA says the unit needs to be replaced in the "near future", but doesn't give a more specific timeline.
- d) Financial:
 - i. Updates: none
 - ii. Budget 2023: Mary Kate was unable to submit the Library budget to Council as directed at the January meeting because the municipality has a different budget process this year and had already included an amount for the library levy in the municipal budget without Library input. The Board expressed concern about this change to the budget process, in light of the requirements of the Public Libraries Act and the municipal auditor's comments in 2019. Mary Kate has been offered an opportunity to present the Library's budget request as a delegation on Feb 27 (after Council fiishes their preliminary review of the budget, but before the final decision, according to the budget schedule). Given the delayed budget presentation and the pending new water unit, the Board discussed revising the capital building grant

request.

MOTION: to adjust the 2023 budget request for the Capital Building Grant to \$5,000 to include the cost of replacing the water unit. Moved by: Brian; seconded by: Olivia. **APPROVED.**

January use stats are picking up. There were some very slow days due to the weather, but also a lot of programs and meetings. Circulation is up (physical & e-collection). Use is similar to pre-pandemic, except that there continue to be fewer visits from youth and lower computer use.

Programs & Services:

Children's Programs:

StoryTime, French StoryTime, Saturday Play Days, Class visits, and Playgroup visits are running regularly.

Upcoming: Valentines program (Feb 11- for preschoolers & primary grades), children's activities during the **Snowflake Festival** (Feb 20), have started planning for March Break activities & another Art4Youth workshop. **Group Visits:** continuing to make story visits to PlayGroup (most weeks) and Daycare (monthly).

Class Visits: continuing to get visits to the Library from 3 Ste-Marguerite classes, 1 Merrickville school class, and some Merrick Prep students. Will be making librarian visits to 2 Merrickville classes for Valentines Day. **Eco-Champions** is starting up again; will go into high gear in March.

Adult Programs:

Currently running: Off the Shelf, Library Book Club, Fitness for your Aging Brain, the Meditation drop-in (Health Centre) and the Hospice Satellite Office (Beth Donovan Hospice). Have started hosting a knitting group, and a new adult art group is starting in Feb.

The Merrickville Ladies Club has approached us about reviving the adult art group and hosting a knitting group.

The Seed Library will be starting up again in March. Seedy Saturday is scheduled for Apr 22.

Internet/Computers: use levels remain consistent. **InterLibrary Loans:** use levels remain consistent.

Meeting Room: Is being used regularly for programs and meetings. Have had new requests.

Collection: Winter bestsellers are coming in. Weeding the non-fiction collection as time permits.

Volunteers: All is good on this front. The volunteers do shelving, processing new books, packaging ILLs, and working on the genealogy collection. A member of the seed library committee has volunteered to help get the seeds and display ready to open.

Facilities: See Other Business (10c). Furnace troubles and water unit issues. One mouse, but the peppermint oil seems to be working well.

Accessibility Plan: Still waiting for feedback re: grab rail.

Publicity/Outreach: Will be submitting in the March Phoenix, but am continuing to keep up the webpage and social media. Am reaching out to the schools re: ECO-Champions, and we are looking to publicize the Seed Library.

Partnerships/Outreach: The Library is running programs with or hosting meetings some new groups: the Merrickville Ladies Club, Beth Donovan Hospice, as well as our familiar partners/community groups: Trails Society, Health Centre, Sustainable Merrickville-Wolford, Eco-Champions, Chamber of Commerce, Fair Board, schools, daycare, Playgroup. Will be running chidren's activities during the Chamber's Snowflake Festival on Family Day.

Professional Development, Meetings, etc: There is a couple of CEO meetings coming up in March and April. I have been invited to do a presentation on the Seed Library at a small libraries conference in May.

Donations: We have received a couple of donations to our fund with OCF.

Grants, etc: Will submit the data for the Annual Survey once I have the updated financial info.

Plans for month: finishing Annual Report and submitting Annual Survey data, budget delegation, programs: planning and running for March Break, etc, working with partners, reopening the Seed Library, more weeding, and the usual library business. Hopefully there will be no furnace, or other building problems.

RE: Voting Process for Appointing a Council Member

OBJECTIVE: To seek Council's approval of the process for voting when filling

the current Council vacancy through the appointment process.

RECOMMENDATION:

THAT: The Council of the Corporation of the Village of Merrickville-Wolford does hereby receive report CAO-02-2023, being a report to describe the voting process for filling the current vacant seat on Council; and

THAT Council does hereby approve the voting process described in report CAO-02-2023 to appoint a person who has consented to accept the office to fill the current vacant seat on Council for Merrickville Ward.

BACKGROUND:

The *Municipal Act*, 2001, c.25, Section 259(1)(d), indicates that the office of a member of council of a municipality becomes vacant if the member resigns from his or her office in accordance with Section 260. Section 260 indicates that a member of council of a municipality may resign from office by notice in writing filed with the Clerk of the municipality.

On January 25, 2023, Councillor Mark Oldfield submitted notice in writing with the Clerk of his resignation from his Merrickville Ward Councillor seat. In Council's next meeting on January 30, 2023, Council declared the Council seat vacant via Resolution R-028-23 (Schedule 'A') in compliance with Section 262(1) which requires Council to declare the office to be vacant at its next meeting following submission of the resignation.

On February 27, 2023, Council decided via Resolution R-066-23 (Schedule 'B'), in compliance with Section 263, that they would appoint a qualified person who has consented to accept the office of Councillor – Merrickville Ward to fill the current vacant seat on Council, rather than hold a by-election. Council also directed staff to contact all candidates for the Merrickville Ward and Mayor in the 2022 Municipal Election for written expressions of interest to be appointed to office if accepted.

On March 2, 2023, the Clerk reached out to the four eligible candidates based on Council's direction for their expressions of interest in being considered for appointment (Schedule 'C'). The request was to indicate the candidate's consent to be considered for appointment, or to indicate that they are not interested in being considered, and to provide written expression of interest for Council consideration by the deadline of Friday March 10, 2023 at 12:00 p.m.

ANALYSIS:

The process that was followed when filling the vacant Council seat in 2021 was vetted with the Village's lawyer and is recommended for use with the current vacancy to maintain consistency. It was confirmed that the Clerk should read all the names of the consenting candidates in alphabetical order and each current member of Council is then given one vote. Council members will vote in random order and the consenting candidate that gets the majority of votes is appointed.

Two of the four candidates that the Clerk contacted declined the invitation and the other two accepted it. The candidates that responded indicating, "Yes, I am interested and consent to being appointed to the vacant Council seat for Councillor - Merrickville Ward for the remainder of the current term should Council choose to appoint me" are:

- Anne Barr
- Yves Grandmaitre

Normally, in the event of a tie vote with more than two willing candidates, all candidates other then the two that tied are eliminated and the two candidates who tied are voted on a second time. In the current situation with only two willing candidates, a tie vote will still result in a second vote to give all Council members an opportunity to adjust their vote if they so choose.

If the second vote again results in a tie, then the names of the two tied candidates will be drawn by the Clerk from a hat, opaque bowl, or other suitable container. All ballots must be the same size and material. The name of the candidate that is first drawn from the container is appointed.

As indicated in the March 2, 2023 email to the 2022 Municipal Election candidates for Merrickville Ward and Mayor, the onus has been placed upon the candidates to determine if they are legally qualified to hold office and the eligibility requirements were provided to them by Clerk. The new Councillor will serve from the time that their oath of office is taken until the end of the current term of Council.
