Delegations: Sgt. Paul Legault, Acting Sgt. Gilbert Cadieux

A presentation was made regarding the 2013-2017 OPP contract.

The OPP have requested the Board make a recommendation to Council regarding the new contract. Sgt. Legault explained there is an opportunity to change the Full Time Equivalent (FTE) rate thought a decrease of 0.22 or Council can indicate it wishes to stay with the current 3 FTE for the municipality. The contract for 2013-2017 shows a decrease in cost of .56% from the previous contract.

It was noted there will be an increase in salaries in 2014 of 8.5% however it was pointed out the increase is applied to the salary line and not the overall contract cost. It was also noted that there is a salary freeze in effect until 2014 and it is anticipated there will be a further freeze in 2015 and 2016. This would mean an overall increase of approximately 2% per year over the five year contract.

The Board will recommend to Council that it maintain the status quo and not reduce the FTE by .22 percent.
