

- 1. The Owner acknowledges and agrees that this Agreement shall apply to the Subject Lands described in Schedule A to this Agreement.
- 2. The Owner acknowledges and agrees that the following recommendations provided for in the "Noise Study Merrickville Lot Severance (Kirkpatrick)" and dated July 15, 2021 and attached hereto as Schedule "B" must be adhered to:
 - a) Prior to the issuance of a building permit, a Final Acoustical Report shall be provided to the Village based on the final site layout and building concepts. The Final Acoustical Report will verify the results of the July 15, 2021 Preliminary Acoustical Report and determine specific mitigation measures (including physical mitigation) and warning clauses required, based on the site and the buildings at final design. The submission for a building permit will demonstrate the implementation of the recommendations of the Final Acoustical Report.
 - b) It is understood that due to the expected exceedance of road noise criteria, physical mitigation of noise may be required for outdoor living areas. Physical mitigation may need to take the form of noise barriers, to be determined when the site plan and architectural plans have been prepared. The Owner agrees to implement the recommendations for physical mitigation through the building permit process.
- 3. That the Owner agrees to the following notice being placed on all future offers of purchase and sale:

"All dwelling units to be constructed on the subject lands must include the installation of central air conditioning. Installation of central air conditioning by the Owner will allow windows and exterior doors to remain closed, thereby

ensuring that the indoor sound levels are within the sound level limits of the Municipality and the Ministry of the Environment."

- 4. The Owner hereby consents and agrees that this Agreement shall be registered on title to the Subject Lands at the sole expense of the Owner and that the Village Clerk be so notified of the registration.
- 5. The Owner hereby warrants to the Municipality that the recitals to this Agreement are true.
- 6. This Agreement shall enure to the benefit of the parties hereto and their respective heirs, executors, administrators, successors, successors in title and assigns.





OBJECTIVE:	To provide Council with information on unbudgeted repairs
	needed for the 2011 John Deere backhoe.

RECOMMENDATION:

THAT: Council receive report PW-05-2021, being a report on critical repairs needed for the 2011 John Deere SJ310 backhoe; and

_____ THAT Council does hereby approve and direct staff to secure Brandt Tractor Ltd. to repair the 2011 John Deere backhoe for the quoted price of \$27,238.91.

BACKGROUND:

The John Deere backhoe is a critical piece of equipment that public works staff use daily. The machine is operated year-round for ditching, road repairs, winter operations and landfill operations. The backhoe is having hydraulic issues and staff contacted a John Deere certified mechanic at Brandt Tractor Ltd. to diagnose the issue with the machine. The backhoe was taken to the dealer's shop in Ottawa so they could properly work on the machine. The machine was taken apart at the dealership and it was found to need significant hydraulic repairs.

ANALYSIS:

The rear control valve has failed, an additional four valve sections have also failed, and the main spools are scored and sticking in the valve bodies. After the disassembly of the control valve and inspection of the parts, they have determined that the hydraulic system has contamination in it, that is causing the scoring. The four hydraulic sections that have failed are pilot operated valves. The dealership has removed and inspected both pilot controllers and found scoring on the internal parts. Brandt Tractor estimates it will cost \$27,238.91 to repair the backhoe.

Brandt Tractor Ltd. recommends the following repairs: replace both pilot controllers, replace the main backhoe control valve assembly, flush the hydraulic tank and fill with new hydraulic oil. The required parts are John Deere specific; if they are purchased from another dealership, the parts will not come with a warranty. Additionally, the parts could damage the machine further. Staff have looked at other options of fixing the

machine, by way of finding a used machine for parts, but there are few options for parts and they are very expensive to purchase.

RECOMMENDATION

Staff recommends that the dealership repair the machine, as it is critical for daily operations work and is needed for the upcoming winter maintenance season. As this is an unbudgeted expense, staff recommend that the funds be taken from the year end surplus (if there is one) or a reserve.

BUDGET/LEGAL IMPLICATIONS:

This repair is not within the operating budget for the current year and would have to be funded either from the year end surplus or a reserve.

LINKS TO STRATEGIC PLANS:

On January 23, 2017, the Council of the Corporation of the Village of Merrickville-Wolford passed By-Law 10-17, being a by-law to adopt the Merrickville-Wolford Strategic Plan 2017-2025.

The priorities of the strategic plan that can be linked to this report are as follows:

Ensuring efficient, effective services and civic engagement: By offering a great customer service experience and instilling confidence in Municipal spending by being able to make this information available to Council and the public ensures transparency and is in keeping with the priority to ensure efficient and effective services are being delivered to the residents of Merrickville-Wolford.

CONCLUSION:

Staff are asking Council to authorize repairs to the 2011 John Deere backhoe.

NOW THEREFORE the Council of the Corporation of the Village of Merrickville-Wolford hereby enacts as follows:


