



# How PSFDH Capital Equipment is Funded?

- The Ministry of Health and Long Term Care and the LHIN do not fund annual equipment needs of a Hospital.
- Hospitals are required to identify funding sources to purchase needed equipment each year.
- Traditionally Hospital Foundations and Auxiliaries are the main funding sources for hospital equipment.





# How PSFDH Capital Equipment is Funded?

### Annual Equipment Funding Challenge

# The "Ask" of Our Municipalities:

# Notes: Hospital Funding

- Quality Based Procedures (QBPs):
  - Reimburses health care providers for the types and quantities of patients they treat, using evidence-informed rates that are associated with the quality of care delivered.
  - Ex.: a patient who has a total knee replacement needs both surgery and rehabilitation. Quality-Based Procedures set out how much money each health care provider receives for their contribution to that patient's care journey.
  - Over the next three years, base funding(PSFDH Base- 18.5 million) will be reduced in proportion as funding for Quality-Based Procedures increases





**OBJECTIVE:** 

To obtain a resolution of Council to grant relief of Section 3 of the Fence By-law 21-96, as amended.

## **RECOMMENDATION:**

## That Council receive report CBO-07-2018 and

1. That Council review the applicant's request and give favourable consideration

2. That Council pass a resolution that would grant relief of Section 3 of the Fence By-law as it pertains to 223 Wellington Street East, only.

## BACKGROUND:

The Village of Merrickville Fence By-law 21-96 was passed by the then Council on July 15<sup>th</sup>, 1996 and amended on January 10<sup>th</sup>, 2005. The amendment prescribed enforcement provisions only.

The purpose and intent of the By-law (Copy attached) was to prescribe regulations for the construction, height and dimensions of fences in the then Village of Merrickville as permitted in the <u>Municipal Act</u>, c M.45, RSO 1990.

Despite the amalgamation of the Village of Merrickville with the Township of Wolford in January 1998, the By-law is still valid for the area within the former Merrickville.

## **ANALYSIS:**

A request was made of this Office on August 29th, 2018 for review of the location of a proposed fence at the property at 223 Wellington Street East.

The subject property is located within an "R-1 Residential" Zone. It encompasses a single dwelling which is a permitted primary use for that zone.

The property is a corner lot located at the northwest intersection of Church Street and Wellington Street East. In accordance to the definitions in the Village Zoning By-law, the front lot line is deemed to be the shorter of the two property lines facing the streets.

Therefore, the property line abutting Wellington Street East is deemed to be the front lot line. The lot line adjacent to Church Street is deemed to be an exterior lot line or "outside side yard line" in the Fence By-law.

Section 3 of the Fence By-law reads as follows:

"a fence on a front lot line and any outside side yard line and on any inside side yard line from the front edge of the house or main structure to the front lot line shall be limited to a height of 1.22 metres (4 feet) and such a fence may be opaque or open weave."

The purpose of this section is to avoid the possibility of potential accidents because of limited visibility of pedestrians on sidewalks and vehicle traffic due to the height of a fence.

The property owner wishes to construct a 1.8 metre opaque privacy fence on the outside side yard line beside Church Street. At present, there is no fence in this location and the owner is experiencing unauthorized public crossing through her lands day and night.

The owner is concerned that a fence of only 1.22 metres in height will not adequately deter the unauthorized public crossing through her property nor will it afford her any privacy.

A site inspection of the premises was carried out by staff with the owner and contractor on August 29<sup>th</sup> of this year. There is no sidewalk on Church Street, however there is a defined concrete curb. The approximate location of the property lines was discussed but no survey pins were found.

The site inspection did not reveal any potential hazards to pedestrians at the location of the proposed 1.8 metre fence.

Nonetheless, the owner and contractor were made well aware that despite any relief that Council may grant for a 1.8 metre high fence constructed at this location, the Zoning By-law will not allow the maximum height of any fence to exceed 0.8 metres within the sight triangle of the street intersections. A sight triangle is the triangular space formed from a point measured back 7.5 metres along the property lines at the intersection of the two streets.

The owner provided a written request for relief of Section 3 of the Fence By-law. (Copy attached)

## BY-LAW No. 21-96

BEING a By-Law to prescribe regulations governing the construction, height and description of fences of any type

WHEREAS section 210 (25) of the Municipal Act c. M.45 R.S.O. 1990 as amended does allow for the passing of By-Laws for prescribing the height and description of lawful fences and for prescribing the area of the municipality to which the By-Law applies

AND WHEREAS with the growth of the Village of Merrickville a By-Law prescribing the height and description of fences is deemed to now be necessary.

NOW THEREFOR the Council of the Corporation of the Village of Merrickville does enact as follows that:

- 1. this By-Law shall apply to the whole corporate area of the Village of Merrickville
- a fence on a rear lot line and an inside side yard from the rear lot line to a point equal to the front edge of the house or main structure shall be limited to a height of 1.81 metres (6 ft.) and may be opaque. The height may be increased to a maximum of 2 metres (6ft. 8in.) over the opaque height if the additional height is constructed of an open weave pattern (e.g. lattice) so that air may freely pass through
- a fence on a front lot line and any outside side yard line and on any inside side yard line from the front edge of the house or main structure to the front lot line shall be limited to a height of 1.22 metres (4 ft.) and such a fence may be opaque or open weave
- a fence may be constructed out of normal construction material. Save for wire fences on the front yard or outside side yard without amendment to this By-Law
- 5. all fences shall be constructed in a manner and appearance in keeping with the neighbourhood in which it is located
- 6: no fence shall be painted in or made from luminous or reflective material
- 7. no fence shall use or incorporate 'barbed wire' or 'electrification' in any manner whatsoever (sec. 210 (28) c.M.45 R.S.O. 1990)
- 8. this By-Law supersedes any other By-Law respecting fences save and except for By-Law No. 10-77 being the By-Law to regulate fences around outdoor swimming pools
- this By-Law has no retroactive clauses and does not apply to any fence existing at the date of passage hereof save that all new fences shall comply
- 10. all fences shall be constructed, with the 'good' side out and within the property line(s)
- 11. the provisions of sections 1 and 2 do not apply to a person who erects or causes to be erected, a privately owned outdoor tennis court.
- 12. an owner, or occupant, of any fence shall have the right to enter upon adjoining land for the purpose of maintaining the fence. However, the owner, or occupant, of the fence shall inform the owner or occupant of the adjoining land of the intention to maintain. The adjoining land shall be left in the same condition as it was prior to such entry

- 13. a hedge when located on the perimeter of a property, shall be maintained so as:
  - a) not to encroach upon or interfere with any sidewalk, highway, traffic sign, fire hydrant, valve or other public utility connection or of a neighbouring property;
  - b) not to become overgrown to the extent that visibility or access to the main entrance or driveway of any dwelling, whether the owner or adjacent property is limited for the ingress or egress of vehicles

## **BACKGROUND:**

In 2010, the appointment of a Compliance Audit Committee was made mandatory through changes to the *Municipal Elections Act*. The Committee is responsible for handling complaints regarding election campaign finances as outlined in the Act and the Terms of Reference, attached as Schedule "A".

The Clerks of Leeds and Grenville created a subgroup who was responsible for drafting the attached terms of reference, receiving and reviewing applications, and making recommendations regarding who should be appointed to the Committee.

In early June, 2018, the advertisement as attached in Schedule "B" was released to various media groups across the United Counties of Leeds and Grenville requesting applications be submitted, with the deadline of June 29, 2018. The deadline for appointing members to the Committee is October 1, 2018.

#### **ANALYSIS:**

An elector, who is entitled to vote in an election and believes on reasonable grounds that a candidate or a registered third party has contravened a provision of the *Municipal Elections Act* relating to election campaign finances, may apply for a compliance audit of the candidate's or the registered third party's campaign finances. The Clerk shall also submit requests for review with respect to any contributor who appears to have

contravened any of the contribution limits to a candidate's election campaign or to a registered third party's election campaign.

The Clerks of Leeds and Grenville support a continued joint approach to pool resources and to ensure qualified appointees. As such, a joint Compliance Audit Committee has been appointed by all municipalities in Leeds and Grenville since 2010. Further, in order to streamline efforts in administering required Compliance Audit Committee meetings, local Clerks are recommending the County Clerk act as the secretary for the Committee.

The Compliance Audit Committee subgroup reviewed the applications and have recommended Rob Bickerton, Mel Campbell, Charles Kellington, Bill Pakeman and Glenn Mackey as the successful appointees. To date, no Council of any of the participating municipalities have found these recommendations to be unfavourable.

#### **BUDGET/LEGAL IMPLICATIONS:**

Appointed members in good standing will be provided a \$100 annual honorarium. This cost will be shared amongst all participating municipalities. Additional compensation may be provided to members if called upon, depending on the compensation policies of the municipality requiring their services.

## **INTERDEPARTMENTAL IMPACTS:**

Not applicable.

#### **LINKS TO STRATEGIC PLANS:**

On January 23, 2017, the Council of the Corporation of the Village of Merrickville-Wolford passed By-Law 10-17, being a by-law to adopt the Merrickville-Wolford Strategic Plan 2017-2025.

Ensuring efficient, effective services and civic engagement.

By working together with neighbouring municipalities, complying with the *Municipal Elections Act* in respect of the Compliance Audit Committee has and will continue to save considerable staff time as well as monetary resources as the costs associated with the advertising, honorariums, etc. will be shared amongst the municipalities involved.

## 4 Membership

The Committee shall be composed of three (3) voting members, with up to three (3) alternate members that would assume all the rights and privileges of a voting member if called upon to replace a voting member at the discretion of the County Clerk.

Membership will be comprised of individuals with legal, election administration, public administration, auditing and/or accounting experience, professionals who are required to adhere to codes of standards of their profession and those with in-depth knowledge of the campaign financing rules of the *Municipal Elections Act.* 1996.

Pursuant to subsection 88.37(2) of the *Municipal Elections Act, 1996* applicants cannot be candidates or registered third party advertisers in the 2018 Municipal Election, or any by-election during the 2018-2022 Council term, nor can they have committed to providing professional accounting advice to any person running for office in any of the participating municipalities. Municipal employees and members of Council are also ineligible.

Members will be required to take Accessible Customer Service training as a condition of appointment.

## 5 <u>Membership Selection</u>

The Terms of Reference and application form will be posted on the municipal websites of the participating municipalities. Clerks of the participating municipalities may also contact and solicit individuals with experience as set out under section 4 of the Terms of Reference. In addition, advertisements will be placed in a local paper.

All applicants will be required to complete an application form outlining their qualifications and experience. Clerks of the participating municipalities may interview eligible applicants who meet the selection criteria. A list of recommended candidates will be submitted to the Council of each participating municipality for consideration.

The selection process will be based upon the following criteria:

- a. demonstrated knowledge and understanding of municipal election campaign financing rules;
- b. proven analytical and decision-making skills;
- c. experience working on a committee, task force or similar setting;
- d. availability and willingness to attend meetings; and
- e. possession of excellent oral and written communication skills.

## 6 Conflict of Interest

Pursuant to subsection 88.37(2) of the *Municipal Elections Act, 1996* applicants cannot be candidates or registered third party advertisers in the 2018 Municipal Election, or any by-election during the 2018-2022 Council term, nor can they have committed to

providing professional advice to any person running for office in any of the participating municipalities. Municipal employees and members of Council are also ineligible.

Failure to adhere to these requirements will result in the individual being removed from the Committee.

## 7 Compensation

Voting and Alternate Members will be provided with an annual retainer of \$100 at the end of each year of the term. The County Clerk will issue payment to each member in good standing on behalf of participating municipalities who will divide the costs evenly amongst themselves.

Members may receive additional compensation depending on compensation by-laws of the local municipalities.

## 8 Chair

The Committee will select a Chair from amongst its members at its first meeting upon receipt of each compliance audit application or Clerk's report.

The Chair is the liaison between the members and the Secretary of the Committee on matters of policy and process.

The Chair shall enforce the observance of order and decorum among the Committee members and those present at all meetings.

When the Chair is absent, the Committee may appoint another member as Acting Chair. While presiding, the Acting Chair shall have all the powers of the Chair.

## 9 Staffing and Funding

The County Clerk or designate shall act as the Secretary to the Committee.

The participating municipality requiring the services of the Committee shall be responsible for all associated expenses, in addition to a portion of the retainer fee referred to above in Section 7.

## 10 Meetings

While meetings of the Committee will be open to the public, Sections 88.33 (5.1), 88.34 (9.1) and 88.35 (6.1) of the *Municipal Elections Act, 1996* state that the Committee may choose to deliberate in private

## Timing of Meetings

Applications shall be forwarded to the Clerk of the municipality where the audit is being requested and he/she shall then forward the application to the County Clerk

immediately upon receipt, noting the date and time the application was received. The application shall be provided to the Compliance Audit Committee within 10 days of its receipt at the local municipality in accordance with S. 88.33(4). Also upon receipt of an application the County Clerk or designate will determine the date and time of the first meeting in consultation with the members. Subsequent meetings will be held at the call of the Chair in consultation with the County Clerk or designate.

Committee activity shall be determined primarily by the number and complexity of applications for compliance audits that may be received. The frequency and duration of meetings will be determined by the Committee in consultation with the County Clerk or designate.

## Meeting Location

The Committee shall meet at the location determined by the County Clerk.

#### Members

An alternate member may be used in the following circumstances at the discretion of the County Clerk:

- a committee member is an eligible elector in the municipality requiring the audit;
- a committee member is unavailable for the duration of the audit.

The County Clerk or designate will confirm the committee membership.

## Meeting Notices, Agendas & Minutes

Reasonable notice of the meetings of the Committee shall be given to the candidate, the applicant, the contributor, and/or the registered third party, depending on the type of application being considered, the Clerk of the municipality where the application was requested and the public.

The County Clerk or designate shall cause notice of the meeting(s) to be provided a minimum of two (2) business days prior to the date of each meeting. The agendas and minutes of meetings shall be posted on the municipal website of the United Counties of Leeds and Grenville and on the website of the municipality requesting the services of the Compliance Audit Committee.

Minutes of each meeting shall outline the general deliberations and specific actions and recommendations that result.

The Committee must provide brief written reasons for decisions made with respect to acceptance or rejection of the application, and whether legal proceedings will be commenced following the receipt of an auditor's report.

These written reasons must be provided to the candidate, the County Clerk, the Clerk for the municipality where the candidate filed his or her nomination, the applicant, the contributor, and/or the registered third party, depending on the type of application being considered.

## Agenda Format

- 1. Call to Order
- 2. Appoint Chair (first meeting only)
- 3. Disclosure of Pecuniary Interest and General Nature Thereof
- 4. Consideration of Compliance Audit Application or Auditor's Report
- 5. Adjournment

#### Quorum

Quorum for meetings shall consist of a simple majority of the members of the Committee.

If no quorum is present thirty (30) minutes after the time appointed for a meeting, the County Clerk or designate shall record the names of the members present and the meeting shall stand adjourned until the date of the next meeting, as determined by the County Clerk or designate, or the Chair, if appointed.

## Meeting Attendance

Any member of the Committee who is absent from two (2) consecutive meetings without excusal by the Committee may be removed from the Committee at the discretion of the County Clerk or designate in consultation with the Clerks of the participating municipalities.

## Motions & Voting

A motion shall only need to be formally moved before the Chair can put the question or a motion can be recorded in the minutes.

Every Member present shall be deemed to vote against the motion if they decline or abstain from voting, unless disqualified from voting by reason of a declared pecuniary interest.

In the case of a tie vote, the motion shall be considered to have been lost.

The manner of determining the vote on a motion shall be by show of hands.

The Chair shall announce the result of every vote.

## 11 Administrative Practices and Procedures

The Terms of Reference constitute the Administrative Practices and Procedures of the Committee. Any responsibilities not clearly identified within these Terms of Reference shall be in accordance with Section 88.33 to 88.37 of the *Municipal Elections Act*, 1996.

All participating Clerks have the right to develop additional administrative practices and procedures.

#### Compliance audit of candidates' campaign finances

#### Application by elector

- (3) The application must be made within 90 days after the latest of the following dates:
- 1. The filing date under section 88.30.
- 2. The date the candidate filed a financial statement, if the statement was filed within 30 days after the applicable filing date under section 88.30.
- 3. The candidate's supplementary filing date, if any, under section 88.30.
- 4. The date on which the candidate's extension, if any, under subsection 88.23 (6) expires. 2016, c. 15, s. 63.

#### Compliance audit committee

(4) Within 10 days after receiving the application, the clerk of the municipality or the secretary of the local board, as the case may be, shall forward the application to the compliance audit committee. 2016, c. 15, s. 63.

#### Notice of meetings

(5) Reasonable notice of the meetings of the committee under this section shall be given to the candidate, the applicant and the public. 2017, c. 20, Sched. 10, s. 1.

#### Open meetings

(5.1) The meetings of the committee under this section shall be open to the public, but the committee may deliberate in private. 2017, c. 20, Sched. 10, s. 1.

#### Same

(6) Subsection (5.1) applies despite sections 207 and 208.1 of the Education Act. 2017, c. 20, Sched. 10, s. 1.

#### Decision of committee

(7) Within 30 days after the committee has received the application, the committee shall consider the application and decide whether it should be granted or rejected. 2016, c. 15, s. 63.

#### Same

(8) The decision of the committee to grant or reject the application, and brief written reasons for the decision, shall be given to the candidate, the clerk with whom the candidate filed his or her nomination, the secretary of the local board, if applicable, and the applicant. 2016, c. 15, s. 63.

#### Appeal

(9) The decision of the committee under subsection (7) may be appealed to the Superior Court of Justice within 15 days after the decision is made, and the court may make any decision the committee could have made. 2016, c. 15, s. 63.

#### Appointment of auditor

(10) If the committee decides under subsection (7) to grant the application, it shall appoint an auditor to conduct a compliance audit of the candidate's election campaign finances. 2016, c. 15, s. 63.

#### Same

(11) Only auditors licensed under the *Public Accounting Act, 2004* or prescribed persons are eligible to be appointed under subsection (10). 2016, c. 15, s. 63.

#### **Duty of auditor**

(12) The auditor shall promptly conduct an audit of the candidate's election campaign finances to determine whether he or she has complied with the provisions of this Act relating to election campaign finances and shall prepare a report outlining any apparent contravention by the candidate. 2016, c. 15, s. 63.

#### Who receives report

(13) The auditor shall submit the report to the candidate, the clerk with whom the candidate filed his or her nomination, the secretary of the local board, if applicable, and the applicant. 2016, c. 15, s. 63.

#### Report to be forwarded to committee

(14) Within 10 days after receiving the report, the clerk of the municipality or the secretary of the local board shall forward the report to the compliance audit committee. 2016, c. 15, s. 63.

#### Powers of auditor

- (15) For the purpose of the audit, the auditor,
- (a) is entitled to have access, at all reasonable hours, to all relevant books, papers, documents or things of the candidate and of the municipality or local board; and
- (b) has the powers set out in section 33 of the *Public Inquiries Act, 2009* and section 33 applies to the audit. 2016, c. 15, s. 63.

#### Costs

(16) The municipality or local board shall pay the auditor's costs of performing the audit. 2016, c. 15, s. 63.

#### Decision

(17) The committee shall consider the report within 30 days after receiving it and, if the report concludes that the candidate appears to have contravened a provision of the Act relating to election campaign finances, the committee shall decide whether to commence a legal proceeding against the candidate for the apparent contravention. 2016, c. 15, s. 63.

#### Notice of decision, reasons

(18) The decision of the committee under subsection (17), and brief written reasons for the decision, shall be given to the candidate, the clerk with whom the candidate filed his or her nomination, the secretary of the local board, if applicable, and the applicant. 2016, c. 15, s. 63.

#### **Immunity**

(19) No action or other proceeding for damages shall be instituted against an auditor appointed under subsection (10) for any act done in good faith in the execution or intended execution of the audit or for any alleged neglect or default in its execution in good faith. 2016, c. 15, s. 63.

#### Saving provision

(20) This section does not prevent a person from laying a charge or taking any other legal action, at any time, with respect to an alleged contravention of a provision of this Act relating to election campaign finances. 2016, c. 15, s. 63.

Applicants may be required to participate in an interview process.
