5. Business Items

Request for Heritage Designation of McGuigan Cemetery

 Anne Barr reviewed the following documents had been distributed to the committee prior to the meeting. These were provided to the committee to help us understand the process and the roles.

i)Ontario Regulation 9/06 -criteria for determining cultural heritage value or interest

A property must have at least 1 of the 9 criteria, it doesn't have to be a building, it can be something like a feature, a landmark, a place.

ii)Ontario Heritage Act, R.S.O. 1990, c. O.18PART III.1

This document outlines the municipalities' authority to designate heritage properties.

iii)Standards and Guidelines for provincial heritage properties

Flowchart that outlines the steps that need to be taken to designate a property. Each designation, repeal, alteration process is laid out.

iv)The Standards & Guidelines for the Conservation of Historic Places in Canada

This is the formally adopted guidelines that are followed by Merrrickville-Wolford. This is a federal document. Conservation can mean preservation, rehabilitation or adaptive reuse or restoration. This document allows us to be flexible but promotes the use of these heritage properties. We currently have 32 designated properties (highest designated properties per capita)

v)Heritage Designation and Property Values: Is there an Effect? Robert Shipley University of Waterloo Ontario Canada

The consensus is that a designation increases the value of the property and makes it easier to sell.

vi)Heritage Property - Owners Guide

A website that gives a good overview and answers questions about heritage properties.
