# OAPSB ANNUAL MEETING

Mayor Struthers and Chairman Bower provided a verbal report of the OAPSB Annual Meeting held in Toronto in May. The Mayor noted that there was discussion regarding the contracts and the arbitration process. There was also discussion about programs being run in Scotland and other parts of Ontario which focus on teens and the evaluation of home-life as a crime prevention strategy. Chairman Bower mirrored the Mayor's comment adding that there were similar projects in the Sudbury hub. He also briefly discussed the session on expanded roles for special constables which was a dismal presentation which ended with the presenters stating the OPP would not touch the program. He also mentioned there is a company that offers police checks at a cost however Insp. Bedard noted the OPP uses retired members to conduct the checks. Chairman Bower also indicated the new President is Ken East.

### CONTRACT PRESENTATION

The Board reviewed the presentation for the June 24, 2013 meeting. OPP will be on hand to present the documents. The Chairman will introduce the members and the OPP will provide the information. Mayor Struthers noted it was positive to see that the report referenced local by-laws.

#### COMMUNICATION

Chairman Bower asked if promotion of the OPP Torch Run was a duty of the Police Services Board. He was advised by Insp. Bedard that it was not a PSB responsibility.

Chairman Bower also noted that there had been official openings of the OPP Headquarters in Smiths Falls yet no Police Service Boards had been invited.
