Business arising from the minutes:

1. The Mayor asked if there was additional information available regarding the OAPSB update provided in the June minutes regarding special constables. The secretary will request a copy of the presentation. It was noted by Insp Bedard that there are special constables in place in the OPP carrying out a variety of duties.

Police Report and Statistics:

- 1. Sgt. Francis reviewed the June report with the Board. He noted that there was a shortage of committed hours in the month of June. He indicated he reviewed the reports for the month and believes that staff absence and misallocation of a number of hours to a neighbouring municipality are the cause. He provided the information that on some occasions constables are assigned to an area and they do not over-ride the pre-set area on their computer data input. The Mayor and Chair noted that this is the first time they can recall the hours being under. The Mayor also stated he was happy to see that the matter was investigated and not merely considered an anomaly.
- 2. Member Moffatt asked if there was a way to prevent the public from jumping off the swing bridge in the evening. It was noted the bridge is under federal jurisdiction however Sgt. Francis indicated he would provide information at a future meeting.

New Business:

- 1. Chairman Bower extended his congratulation to the OPP for their traffic control program during the annual car show.
- 2. Mayor Struthers thanked the OPP for the presentation of the contract to Council.
- 3. The Board noted the 2013 Community Survey was available at the table. It was agreed the item would be placed on the August agenda for discussion.
