Business arising from the minutes:

• Speed Machine – The board members noticed a speed machine on St. Lawrence Street and inquired where the sign came from and who approved it. Mayor Nash said that due to the budget constraints this year it was suggested at Council that they rent or borrow a speed machine. The Public Works Manager was directed to contact North Grenville or Smiths Falls to see if their machines were available to rent or borrow. North Grenville has offered to loan their machine to us for two weeks. D Bower asked Mayor Nash if it could be the discretion of the PSB as to where the machine can be moved to. D Bower said that he has seen that the machine does work when vehicles see it they slow down. Mayor Nash indicated that the Public

Works Manager is responsible for moving the sign therefore if we can give him a list of locations. R Boswell said that we need to prove to Council that the sign works. This is one instrument that we want to get people to reduce their speed going into and out of the town on all the different arteries. Next time if we can compile some information to such as: what motorist are doing now, what they are doing while the sign is there and when the feedback is no longer given to them from the sign. Insp. Bolton said in OPP experience that the machine does work and they are very supportive of this tool. Next time we get the machine we could possibly set it up with the Speed Spy and get detailed information for Council's next budget. It was concluded that the machine should be set up in the following locations: Montague Street, Read Street, County Road 43 just past the railway overpass coming and going from the Village and Mill Street. The board is much appreciative that North Grenville loaned the machine to us. This speed machine has been put on the Action Items list so we can keep revisiting and collecting data for the next year's budget.

Insp. Bolton reviewed the May 2016 report with the Board. In addition the board was given the 2015 Progress Report to review. Secretary asked to put on next agenda.

Insp. Bolton said they are seeing a trend around the county of fraud. A big fraud going on right now is with Canada Customs. They are calling or leaving messages on phones saying you have been identified that you owe all this in back taxes so you need to call a number right away or you will be arrested. There have been victims across the county that have lost thousands of dollars. Insp Bolton said he will drop off pamphlets' to the office with tips to be mindful of and have Cst Cathy Lindsey distribute threw out the municipality.

Mayor Nash indicated that Council had passed a resolution to request an O.P.P. calls for service billing report. Insp Bolton will check with Frederick before he leaves to see what they are looking for and go from there. R Boswell has asked the Mayor if anything in the future that applies to the PSB goes to Council if the members could be contacted and they would also attend the Council Meeting.
