#### New Business:

Trail in association with Ayling's Marina - Councillor Ireland

- A presentation was made at February 13, 2017 Council Meeting in support of Ayling's Marina and Siren Boatyard. There is an "ask" for a trail to be created that would connect the Marina with easy and interesting access to the downtown core. The concept is for a trail to go from the marina over a foot bridge across the bottom of the property at the Ruins and up towards the sidewalk into town across the canal. (understood that this could connect with Rideau Trail)
- CAO Regan was to send note to RAC to ask Trails Sub-Committee but as Trails Committee is not
  a sub-committee request that the note be sent to Trails Committee directly
- This could be an ideal situation for the Trails Committee as it would meet the requirements of their mandate and also fit into the strategic plan
